The minutes of the Regular Meeting of the Village of Haverstraw Board of Trustees on Wednesday, September 4th, 2013, beginning at 8:00 PM.

Mayor Kohut: The Mayor opened the meeting with the first Public Participation inviting the public to ask questions or make comments.

Sherry Coplon, 58 Main Street: Ms. Coplon inquired if the Board passed a chicken law, to which the Mayor responded "No". She then inquired if the Board would be passing such a law in the near future.

Mayor Kohut: The Mayor inquired if there was a particular reason Ms. Coplon was making this inquiry.

Sherry Coplon: Ms. Coplon thought it would be nice to have some chickens in the Village and some people do want to raise chickens, as well as the fact that this has been brought up at previous meetings.

Mayor Kohut: The Mayor stated that the law was proposed but other things came up and the Board never followed through with it. The law is still pending on the agenda if the Board decides it wants to pursue it further, explaining that the law would allow for chickens (hens), but **not roosters.**

Sherry Coplon: Ms. Coplon, being aware of all the cuts to the Head Start Program throughout the Country, inquired if the cuts affect the program in the Village.

Mayor Kohut: The Mayor reported that he was not aware of Head Start having any funding problems.

Francisco Batista: Trustee Batista informed Ms. Coplon that there were no major cuts to the Head Start Program in the Village and they are conducting business as usual.

Terence Watson, Jr.: Trustee Watson also mentioned that they recently purchased the building on Route 9W across from the Exxon Gas Station, which they are using for their offices, with the schooling still being conducted at their facility on Maple Avenue and also Division Street.

Sherry Coplon: Ms. Coplon then inquired how many cell phone towers are currently in the Village and the location of each. She also inquired if there were any new request coming in.

Mayor Kohut: The Mayor responded that there are currently 2 locations where cell towers exist, the first being located at 21 Broadway with 1 provider and the second being located at the Central Presbyterian Church at 89 Hudson Avenue, where there are 2 or 3 providers. He also informed Ms. Coplon that there are no other cell tower applications pending at the current time.

Sherry Coplon: Ms. Coplon then referred back to the chicken law, stating that she realizes it is not a top priority but she feels that people should be able to keep a few hens, as some people already do in the Village and thinks it should be made legal to do so.

Mayor Kohut: The Mayor stated that the Board will take another look at the proposed law and when time allows move forward with it.
